DeCoste (by vote of the town) that the town of Hanover be authorized to grant 13 additional licenses for the sale of alcoholic beverages to be drunk on the premises. An Act authorizing the town of Hanover to grant 13 additional licenses for the sale of alcoholic beverages to be drunk on the premises.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. (a) Notwithstanding section 17 of chapter 138 of the General Laws, the
2 licensing authority of the town of Hanover may grant up to 10 additional licenses for the sale of
3 all alcoholic beverages to be drunk on the premises pursuant to section 12 of said chapter 138
4 and up to 3 additional licenses for the sale of wines and malt beverages to be drunk on the
5 premises pursuant to said section 12 of said chapter 138 to establishments located within the
6 Planned Shopping Center District, what is now known as the Hanover Mall and to become
7 Hanover Crossing, located east of Route 53, north of Mill Street and west of Route 3 as defined
8 by the town's zoning map as it existed as of May 2014. A license granted pursuant to this act
9 shall be clearly marked on its face "Planned Shopping Center District, Hanover Crossing" and
10 shall be subject to all of said chapter 138 except said section 17.

11 (b) The licensing authority shall not approve the transfer of a license granted pursuant to
12 this act to any other location outside of the Planned Shopping Center District, Hanover Crossing,
13 but it may grant any such license to a new applicant within the Planned Shopping Center District,
14 Hanover Crossing if the applicant files with the licensing authority a letter from the department
15 of revenue and a letter from the department of unemployment assistance indicating that the
16 applicant is in good standing with those departments and that all applicable taxes, fees and
17 contributions have been paid.

18 (c) If a license granted pursuant to this act is cancelled, revoked or no longer in use, the
19 license shall be returned physically, with all of the legal rights, privileges and restrictions
20 pertaining thereto, to the licensing authority and the licensing authority may then grant the
21 license to a new applicant to be used at an establishment located within the Planned Shopping
22 Center District, Hanover Crossing under the same conditions specified in this act.

23 (d) Licenses authorized in this act shall be granted within 3 years after the effective date
24 of this act; provided, however, that if the license is originally granted within that time period, it
25 may be granted to a new applicant pursuant to subsections (b) or (c) anytime thereafter.

26 SECTION 2. This act shall take effect upon its passage.
