An Act to ensure equal access to education, including special education services, for all students in Massachusetts.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1I of Chapter 69 of the General Laws, as appearing in the 2016  
2 Official Edition, is hereby amended by inserting after the fifth paragraph the following  
3 paragraph: -

4           The department shall annually analyze and publish in an easily accessible and user  
5 friendly manner the student-specific data provided by school committees and charter schools  
6 pursuant to: section 1I of Chapter 69 of the General Laws; sections 37H, 37O, 37P, and 89 of  
7 Chapter 71 of the General Laws; sections 3 and 7 of Chapter 71A of the General Laws; section 6  
8 of Chapter 71B of the General Laws; section 2A of Chapter 72 of the General Laws; statewide  
9 assessment data utilized as a basis for competency determinations pursuant to section 1D of  
10 chapter 69 of the General Laws; and any other data required by the federal office of education,  
11 provided that said data required by the federal department of education is also student-specific  
12 data and can be cross-tabulated. The department shall provide said data in a manner that can be

13 easily cross-tabulated by, at a minimum, the following: each major racial and ethnic group; sex;  
14 economic status; high needs status; English learner status; and category of disability, if  
15 applicable. The information shall be presented statewide and also disaggregated by school  
16 committee, charter school, and individual school in a manner that is anonymized and does not  
17 reveal personally identifiable information about an individual student. Publication shall include,  
18 but need not be limited to, availability on the department's worldwide web site.

19 SECTION 2. Said Section 1I of Chapter 69 of the General Laws, as appearing in the 2016  
20 Official Edition, is hereby further amended by striking out, in line 235, the word “and” the  
21 second time it appears.

22 SECTION 3. Said Section 1I of Chapter 69 of the General Laws, as appearing in the 2016  
23 Official Edition, is hereby further amended by striking out, in line 237, the period and inserting  
24 in place thereof the following words: - ; and

25 (i) the number of children, by grade level, within each disability category receiving  
26 specific special education services, including but not limited to: each related service; assistive  
27 technology, including but not limited to augmentative and alternative communication;  
28 supplementary aids and services; vocational education; travel training; and community-based  
29 transition services; provided further that school districts and charter schools shall only be  
30 required to provide said information regarding number of children receiving specific special  
31 education services when the department provides school committees with an online web-based  
32 IEP application aligned with the special education services requiring reporting under this  
33 section.

34 SECTION 4. Section 6 of Chapter 71B of the General Laws, as appearing in the 2016  
35 Official Edition, is hereby amended by inserting after the first sentence the following sentences: -  
36 School committees shall also annually report to the department, pursuant to regulations  
37 promulgated by the department, delivery of specific special education services by each major  
38 racial and ethnic group, sex, economic status, and English learner status of children by age level,  
39 including but not limited to delivery of: each related service; assistive technology, including but  
40 not limited to augmentative and alternative communication; supplementary aids and services;  
41 vocational education; travel training; and community-based transition services. This annual  
42 reporting by school committees to the department shall only be required when the department  
43 provides school committees with an online web-based IEP application aligned with the special  
44 education services requiring reporting under this section. This information shall be cross-  
45 tabulated by, at a minimum, the following: each major racial and ethnic group; sex; economic  
46 status; and English learner status. The information shall be presented statewide and also  
47 disaggregated by school committee, charter school, and individual school in a manner that is  
48 anonymized and does not reveal personally identifiable information about an individual student.

49 SECTION 5. Said section 6 of Chapter 71B of the General Laws, as appearing in the  
50 2016 Official Edition, is hereby further amended by inserting, in line 8, after the word  
51 “assignment” the following words: - or pattern of delivery of the aforementioned specific special  
52 education services.
