An Act to establish pilot program for youth development.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding any general or special law to the contrary, this act provides  
2 that there shall be established within the Department of Public Health a pilot program serving  
3 Boston, Brockton, Chelsea, Fall River, Holyoke, Lawrence, Lowell, Lynn, New Bedford,  
4 Springfield and Worcester to demonstrate a coordinated, comprehensive youth development  
5 services delivery system to improve and promote good health, life and academic outcomes  
6 among youth. All programs and activities established or integrated by the pilot programs shall be  
7 coordinated with Executive Office of Health and Human Services state agencies with other  
8 youth-serving programs, agencies and funded programs in each city, in order to optimize the  
9 coordination and allocation of resources.

10           (b) Programs and activities shall be provided outside of school hours, year-round,  
11 including weekends for individuals who are enrolled in school, with programs and activities for  
12 individuals not enrolled in school available on a daily basis.

13 (c) Programs and activities shall be designed based on youth development research  
14 findings, with emphasis directed toward the development and enhancement of social emotional  
15 development, anti-violent and anti-gang behaviors, positive social behaviors, local and statewide  
16 labor pools, job opportunities and career options, civic engagement , financial literacy, and  
17 positive future outlook, community-building, the performing and creative arts, and preventing  
18 teen-age pregnancies. The pilot program shall also include a research component, to track  
19 outcomes and effectiveness of program design and direct services, identify successful practices  
20 and make recommendations for replication and scaling of successful practices, or modification of  
21 unsuccessful practices as indicated by analysis.

22 (d) Pilot program staff and staff at contracting organizations shall reflect the participant  
23 population of the program.

24 (e) The programs and activities provided by the pilot programs shall include but not be  
25 limited to the following: (i) a research component to track outcomes and effectiveness of  
26 program design and direct services, identify successful practices and make recommendations for  
27 replication and scaling of successful practices, or modification of unsuccessful practices as  
28 indicated by analysis; (ii) a community coordination function to assure that service delivery is  
29 coordinated in order to limit unwanted duplication or overlapping; (iii) data collection to support  
30 the research reference in item (i) ; (iv) identification of the services needed to advance the goals  
31 of the program; (v) consideration of the impact of youth worker certification or credentialing on  
32 both inputs to and outcomes of the youth participating in the pilot program (vi) an enhanced  
33 management information system to support a common intake and data tracking systems to  
34 increase the use of services, share resource information, avoid duplication and to allow  
35 participants to engage in, hands-on applications and learn state-of-the-art computer use; (vii)

36 court diversion; (viii) mini-grants to community agencies; (ix) coordination with already  
37 established organizations and agencies; and (x) development of new services required for the  
38 success of the program to the extent that program managers identify gaps in the existing direct  
39 service landscape for youth.

40 (f) There is hereby established and set up an account with the department of public health  
41 to be known as the Youth Development Fund. There shall be credited to said account an amount  
42 sufficient to sustain such the pilot program herein described in fiscal year 2021 commonwealth's  
43 budget, and thereafter for a period of 5 years. Amounts credited to the fund shall not be subject  
44 to further appropriation. Money remaining in the account at the end of a fiscal year shall not  
45 revert to the General Fund and shall be available for expenditure in subsequent fiscal years. An  
46 amount not to exceed \$100,000 shall be spent each year for each pilot program. The fund shall  
47 be credited with: (i) revenue from appropriations or other money authorized by the general court  
48 and specifically designated to be credited to the fund; (ii) interest earned on such revenues; and  
49 (iii) funds from public and private sources such as gifts, grants and donations. Annually, not later  
50 than October 1 the department of public health shall report to the clerks of the house of  
51 representatives and the senate, the house and senate committees on ways and means and the joint  
52 committee on children and families and persons with disabilities on the pilot program's activity.
