An Act relative to the reimbursement of school-based care.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1.

2 Section 9A of Chapter 118E of the General Laws is hereby amended by adding in  
3 subsection (1), after line 34, the following definitions:

4 “Administrative activities,” those activities as defined in the local education authority’s  
5 provider contract with MassHealth, and shall include Medicaid outreach services, facilitation or  
6 assistance in the MassHealth application process, assistance in coordination and delivery of  
7 MassHealth covered services, individual care planning, monitoring, coordination and referrals of  
8 MassHealth covered services, and assistance in obtaining MassHealth-covered transportation or  
9 translation services that are related to MassHealth covered services.

11           “Local education authority,” any city, town, charter school, public health commission, or  
12 school district.

14           “Direct nursing services,” skilled nursing services as defined in the local educational  
15 authority’s provider contract with MassHealth, and shall include mandated grade-level physical,  
16 mental, and behavioral health screening, and nursing treatment/services.

17           “Individualized education program,” a written statement, developed and approved in  
18 accordance with federal special education law in a form established by the Department of  
19 Elementary and Secondary Education of the Commonwealth that identifies a student's special  
20 education needs and describes the services a local education authority shall provide to meet those  
21 needs.

22           “School-age child,” any person of ages three through twenty-two who has not attained a  
23 high school diploma or its equivalent.

24           SECTION 2.

25           Section 9A of Chapter 118E of the General Laws is hereby amended by adding, after  
26 subsection (16), the following subsections:

27           (17) The Executive Office of Health and Human Services together with the Executive  
28 Office of Education shall ensure that each local education authority enrolled with the division as  
29 a MassHealth provider shall implement a plan to obtain MassHealth reimbursement of direct  
30 nursing services, administrative activities and any other medical benefits provided by such local

31 education authority to any school-age child who is an eligible beneficiary of MassHealth in  
32 accordance with this chapter, Title XIX and Title XXI as appropriate.

33 (18) Notwithstanding any other law or regulation to the contrary, any local education  
34 authority enrolled with the division as a MassHealth provider of direct nursing services,  
35 administrative activities and any other medical benefits shall be entitled to submit claims to  
36 MassHealth for reimbursement for providing, by and through its employees or agents, such  
37 services and medical benefits to any school-age child who is an eligible beneficiary. Any direct  
38 nursing services, administrative activities or other medical benefits provided by a local education  
39 authority to a school-age child who is an eligible beneficiary under this chapter shall be  
40 reimbursable by MassHealth regardless of whether said school-age child participates in an  
41 individualized education program, an individual health care plan, or a plan under Section 504 of  
42 the Rehabilitation Act of 1973, or whether said direct nursing services, administrative activities  
43 or other medical benefits are provided at no charge to any school-age child who is not an eligible  
44 beneficiary. Any local education authority claiming reimbursement pursuant to this paragraph  
45 shall first take all reasonable measures to ascertain and pursue any claims for reimbursement for  
46 the direct nursing services, administrative activities and any other medical benefits provided to a  
47 school-age child against legally liable third parties in accordance with Section 1902(a)(25) of the  
48 federal Social Security Act.

49 (19) A nurse employed or contracted by a local education authority enrolled with the  
50 division as a MassHealth provider may submit claims for reimbursement for providing direct  
51 nursing care services, administrative activities or any other medical benefits to a school-age child  
52 under this chapter, provided that the nurse assigns such claims for reimbursement to the local  
53 education authority to the extent required by law.

54           (20) A local education authority which obtains MassHealth reimbursement for providing  
55 direct nursing care services, administrative activities or any other medical benefits to a school-  
56 age child under this chapter, by and through its employees and agents, shall maintain the  
57 proceeds of such reimbursement to fund a program or programs of direct nursing care services  
58 and related administrative activities at any school facility or school system which it operates or  
59 over which it has direct supervision or jurisdiction. Said proceeds shall be used for such purposes  
60 including, without limitation, School Health Services Programming, which may include  
61 behavioral health assessment, case management, health education, social emotional learning and  
62 health support, and other related school health services.
