By Mr. Gentile of Sudbury, a petition (accompanied by bill, House, No. 5118) of Carmine Lawrence Gentile, James B. Eldridge and Michael J. Barrett (by vote of the town) that the town of Sudbury be authorized to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises in said town. Consumer Protection and Professional Licensure. [Local Approval Received.]

**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act authorizing the town of Sudbury to grant an additional license for the sale of alcoholic beverages to be drunk on the premises.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding section 17 of chapter 138 of the General Laws, the
2 licensing authority of the town of Sudbury may grant an additional license for the sale of all
3 alcoholic beverages to be drunk on the premises pursuant to section 12 of said chapter 138, to the
4 holder of a common victualler license for a sit-down restaurant located only in Buildings 2,3,4 or
5 5 within the development known as Meadow Walk, 526-534 Boston Post Road, Sudbury, upon
6 approval of and under conditions set by the licensing authority of the town of Sudbury. A license
7 granted pursuant to this act shall be subject to said chapter 138 except said section 17.

8 SECTION 2. The licensing authority shall not approve the transfer of the license
9 granted pursuant to this act to a location outside of the Meadow Walk development, but it may
10 grant such license to a new applicant within said development if the applicant files with the
11 licensing authority a letter from the department of revenue and a letter from the department of

12 unemployment assistance indicating that the license is in good standing with those departments
13 and that all applicable taxes, fees and contributions have been paid.

14 SECTION 3. If the license granted pursuant to this act is cancelled, revoked or no
15 longer in use, the license shall be returned physically, with all of the legal rights, privileges and
16 restrictions pertaining thereto, to the licensing authority and the licensing authority may then
17 grant the license to a new applicant in the Meadow Walk development under the same conditions
18 as specified in this act.

19 SECTION 4. This act shall take effect upon its passage.
