## In the One Hundred and Ninety-First General Court (2019-2020)

- 1 Ordered, Whereas, COVID-19 is a highly contagious, and at times fatal, respiratory
- 2 disease;
- Whereas, on March 10, 2020, the Governor declared a state of emergency in the Commonwealth
- 4 to respond to the COVID-19 outbreak; and
- 5 Whereas, on December 22, 2020, the Governor issued COVID-19 Order No. 59, Temporarily
- 6 Applying Further Capacity Restrictions to Statewide COVID-19 Safety Rules limiting the size of
- 7 indoor gatherings to 10 people and outdoor gatherings to 25 people; and
- 8 Whereas, pursuant to Article XXX of Part the First of the Constitution of the Commonwealth,
- 9 the Governor's March 10, 2020 declaration of a state of emergency and COVID-19 Order No. 59
- do not apply to the General Court; and

- 11 Whereas, the worldwide outbreak of COVID-19 and the effects of its extreme risk of person-to-12 person transmission significantly affect the life and health of Members, Members-elect, officers and employees, as well as the economy, and is a disaster that impacts the health, security, safety 13 14 and convenience of the public; and 15 Whereas, Article XXII of Part the First of the Constitution of the Commonwealth, advises that
- the General Court "ought frequently to assemble for the redress of grievances, for correcting, strengthening and confirming the laws, and for making new laws, as the common good may 18 require"; and

- Whereas, Article X of the Amendments to the Constitution of the Commonwealth requires that the General Court assemble for the political year on the first Wednesday in January and also authorizes the General Court to assemble "at such other times as they shall judge necessary"; and Whereas, Members of the House of Representatives are required to take and subscribe the oath before the Governor and Governor's Council pursuant to Article I of Chapter VI of Part the
- 25 Whereas, pursuant to Article XXXIII of the Amendments to the Constitution of the 26 Commonwealth, a majority of the Members of the House of Representatives are required to 27 establish a quorum for the transaction of business; and

Second of the Constitution of the Commonwealth; and

28 Whereas, the House of Representatives must, consistent with the guidance of federal and state 29 public health authorities, conduct its business in a manner that will ensure the safety of its 30 Members, Members-elect, officers and employees; and

- 31 Whereas, pursuant to Article X of Section 3 of Chapter 1 of Part the Second of the Constitution
- of the Commonwealth, the House of Representatives has the exclusive constitutional authority to
- 33 settle the rules and orders of proceeding in the House of Representatives; and
- Whereas, the House of Representatives exercised its exclusive constitutional authority to settle
- 35 the rules and orders of proceeding in the House of Representatives for the 191st General Court
- pursuant to Article X of Section 3 of Chapter 1 of Part the Second of the Constitution of the
- 37 Commonwealth on January 30, 2019, hereinafter the Standing Rules and May 4, 2020,
- 38 hereinafter the Emergency Rules; now therefore be it
- 39 Ordered, That, the House of Representatives hereby declares that a state of emergency continues
- 40 to exist within the House of Representatives; and be it further
- Ordered, That, the House of Representatives does hereby exercise its exclusive constitutional
- 42 authority to settle the rules and orders of proceeding in the House of Representatives pursuant to
- 43 Article X of Section 3 of Chapter 1 of Part the Second of the Constitution of the Commonwealth
- 44 by amending the Emergency Rules, in Emergency Rule 1, by striking out the definition of
- 45 "Member" and inserting in place thereof the following 2 definitions:-
- 46 "Member," a Member of the House of Representatives.
- 47 "Member-Elect", a person elected to the House of Representatives for the 192nd General Court
- at the biennial state election held on November 3, 2020.
- And to further amend said Emergency Rules by striking out paragraphs (1) and (2) of subsection
- 50 (a) of Emergency Rule 2 and inserting in place thereof the following paragraphs:-

51 (1) During the state of emergency within the House, the House may assemble for any reason 52 with Members or Members-Elect participating remotely including, without limitation 53 assembling: (i) pursuant to Article X of the Amendments to the Constitution of the 54 Commonwealth; (ii) for purposes of taking and subscribing the oath before the governor and 55 council pursuant to Article I of Chapter VI of Part the Second of the Constitution of the 56 Commonwealth; or (iii) in a formal session. Members participating remotely may vote on any 57 question or other matter before the House. Members or Members-Elect participating remotely 58 shall be considered present and in attendance for all purposes, including for purposes of 59 determining a quorum pursuant to Article XXXIII of the Amendments to the Constitution of the 60 Commonwealth or any Standing Rules and for purposes of taking and subscribing the oath 61 before the governor and council pursuant to Article I of Chapter VI of Part the Second of the 62 Constitution of the Commonwealth. 63 (2) A Member participating remotely shall have the same privileges, rights and responsibilities as 64 if the Member were physically present in the House Chamber, including without limitation, the 65 right, privilege and responsibility to cast votes on all questions or other matters brought to a vote 66 and the ability to the take and subscribe the oath required pursuant to Article I of Chapter VI of 67 Part the Second of the Constitution of the Commonwealth. 68 A Member-Elect participating remotely shall have the same privileges, rights and responsibilities 69 as if the Member-Elect were physically present in the House Chamber, including without 70 limitation, the ability to the take and subscribe the oath required pursuant to Article I of Chapter

VI of Part the Second of the Constitution of the Commonwealth.

- And to further amend said Emergency Rules by striking out Emergency Rule 20 and inserting in
- 73 place thereof the following:-
- 74 Emergency Rule 20. Emergency Rules 1 through 20, inclusive, shall remain effective until a
- 75 majority of the House adopts an Order declaring the state of emergency within the House has
- 76 ceased or until 11:59 P.M. on January 31, 2021.
