An Act allowing 17 year olds to vote in town elections and town meetings.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Notwithstanding section 1 of chapter 51 of the General Laws or any other general or  
2 special law to the contrary, any citizen who; (i) is 17 years of age or older, (ii) meets the  
3 qualifications to be registered as a voter pursuant to section 1 of chapter 51 of the General Laws  
4 except that of age, and (iii) is a resident of the town of Concord at the time they register or pre-  
5 register to vote pursuant to said chapter 51 may vote therein in all town elections, participate and  
6 vote in all town meetings, participate and vote in town caucus and sign all nominating, warrant  
7 and other petitions authorized by town bylaws. A person shall be a registered voter of at least 18  
8 years of age to be eligible to serve in elected town offices or positions.
