**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act relative to election ballots.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 25B of chapter 54 of the General Laws, as so appearing, is hereby
2 amended by striking out from paragraph (h) subsection (1) and inserting in its place the
3 following:-

4 (1) Official ballots, identical in all respects to the official ballots designated in section 44
5 of chapter 54 of the General Laws.

6 SECTION 2. Section 87 of chapter 54 of the General Laws, as so appearing, is hereby
7 amended by striking out paragraph (a) and inserting in its place the following:-

8 (a). Official ballots, identical in all respects to the official ballots designated in section 44
9 of chapter 54 of the General Laws.

10 SECTION 3. This Act shall take effect upon its passage.
