An Act authorizing mushroom picking for personal use on certain state park lands.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 132A of the General Laws is hereby amended by inserting after section 2D the  
2 following section:-

3 Section 2E. The commissioner shall authorize any person to take mushrooms from any  
4 state parks, state forest recreation areas and state reservations under the control of the  
5 commissioner provided such taking is for personal use only. The commonwealth shall have no  
6 liability to any person or the heirs or assigns of any such person who engages in the taking of  
7 mushrooms from any state parks, state forest recreation areas and state reservations under the  
8 control of the commissioner.
