An Act to facilitate the provision of telehealth services.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

- 1           1.     Definitions:
- 2           a.     As used in this section:
- 3           i.     “health professional” means an individual who is engaging in the practice of a
- 4 health profession.
- 5           ii.    “telehealth” means the use of electronic information and telecommunication
- 6 technologies to support or promote long-distance clinical health care, patient and professional
- 7 health-related education, public health or health administration. Telehealth may include, but is
- 8 not limited to, telemedicine.
- 9           iii.   “telehealth service” means a health care service that is provided through
- 10 telehealth.

11           iv.       “telemedicine” means the delivery of a health care service using electronic  
12 communications, information technology, or other electronic or technological means to bridge  
13 the gap between the health care practitioner who is located at one site, and a patient who is  
14 located at a different, remote site, either with or without the assistance of an intervening health  
15 care provider, and in accordance with the provisions of this act. “Telemedicine” does not include  
16 the use, in isolation, of audio-only telephone conversation, electronic mail, instant messaging,  
17 phone text or facsimile transmission.

18           2.       Except otherwise provided in this section, a health professional shall not provide a  
19 telehealth service without directly or indirectly obtaining consent for treatment. This section does  
20 not apply to a health professional who is providing a telehealth service to an inmate who is under  
21 the jurisdiction of the department of corrections and is housed in a correctional facility.

22           3.       A health professional who is providing a telehealth service may prescribe the  
23 patient a drug if both of the following are met:

24           a.       The issuance of a prescription based on a telehealth encounter shall be held to the  
25 same standard of care or practice standards as are applicable to in-person settings.

26           b.       The drug is not a controlled substance.

27           4.       In a manner consistent with this section and in addition to the provisions set forth  
28 in this part, a disciplinary subcommittee may place restrictions or conditions on a health  
29 professional’s ability to provide a telehealth service if the disciplinary subcommittee finds that  
30 the health professional has violated sections 2 or 3.

31           5.     The department, in consultation with a board, may promulgate rules to implement  
32 sections 2 and 3.

33           6.     Sections 2 and 5 do not do any of the following:

34           a.     Require new or additional third party reimbursement for health care services  
35 rendered by a health professional through telehealth.

36           b.     Limit the provision of a health care service otherwise allowed by law.

37           c.     Authorize a health care service otherwise prohibited by law.
