In the One Hundred and Ninety-First General Court (2019-2020)

An Act relative to tobacco premium ratings.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1: Section 3 of Chapter 176J of the General Laws is hereby amended by strking out subsection (5) and replacing it with the following subsection:-
- 3 (5) The commissioner shall annually file with the United States Department of Health
- 4 and Human Services to establish a standard tobacco use factor which shall not exceed a ratio of
- 5 one-to-one. A carrier may apply a tobacco use rate factor in a manner permitted under state and
- 6 federal law that applies to both eligible small groups and eligible individuals; provided, however,
- 7 that the carrier uses a certification of tobacco use process that has been approved by the
- 8 commissioner to determine that eligible individuals and their eligible dependents or eligible
