In the One Hundred and Ninety-First General Court (2019-2020)

An Act relative to community reinvestment goals for banks.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 13 of chapter 167 of the General Laws, as appearing in the 2012 Official Edition,
- 2 is hereby amended by inserting after the first sentence the following 2 sentences:- Each
- 3 supervised bank shall include in its report its community reinvestment goals and outcomes for
- 4 the geographical business area of the bank serves as set forth in section 14. The report shall be
- 5 submitted to each city and town in the commonwealth in the form prescribed by the
- 6 commissioner.
