**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act providing for refrigeration apprentice licenses.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 81 of Chapter 146 of the General Laws, as appearing in the 2016 Official Edition,
2 is hereby amended by striking paragraph 13 and inserting the following:-

3 “Refrigeration Apprentice,” any registered person who is working at the business of
4 refrigeration under the supervision of a master refrigeration technician or journeyman
5 refrigeration technician. Notwithstanding any law to the contrary, an individual who does not
6 have a high school diploma or equivalent certification and is under the age of 18 shall not be
7 eligible to obtain or retain a refrigeration apprentice license unless he or she can document
8 enrollment or completion of a bureau approved chapter 74 vocational-technical program or other
9 such program deemed equivalent by the bureau.
