An Act establishing a residential sustainable energy program.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 The Department of Energy Resources, in conjunction with the Massachusetts
- 2 Development Finance Agency, shall develop and implement regulations to establish a residential
- 3 sustainable energy program to provide financing to residential property owners for energy
- 4 efficient and renewable energy improvements.
