An Act relative to the Farm Technology Review Commission.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding any general or special law to the contrary, the Executive  
2 Office of Energy and Environmental Affairs shall reorganize the Farm Technology Review  
3 Commission established by Section 11, Chapter 310 of the Acts of 2008. The reorganized  
4 commission shall consist of 15 members: 1 of whom shall be the commissioner of the  
5 department of agricultural resources or his designee, who shall serve as chairman; 1 of whom  
6 shall be the commissioner of the department of environmental protection or designee; 1 of whom  
7 shall be the commissioner of the department of revenue or his designee; 1 of whom shall be the  
8 commissioner of the department of public health or his designee; and 11 of whom shall be  
9 appointed by the Governor, 1 of whom shall be a representative from the Massachusetts  
10 technology collaborative, 1 of whom shall be a dairy farmer who is licensed as a producer dealer,

11 1 of whom shall be a dairy farmer who represents the Massachusetts association of dairy farmers,  
12 1 of whom shall be a dairy farmer who represents the Massachusetts cooperative of milk  
13 producers federation, 1 of whom shall be a representative of the Massachusetts Farm Bureau  
14 Federation, 1 of whom shall be a representative of the Cape Cod Cranberry Growers'  
15 Association, 1 of whom shall be a cranberry grower, and 4 of whom shall be a farmer from  
16 additional agricultural sectors. Each member shall serve for a term of 3 years. Any person  
17 appointed to fill a vacancy in the office of a member of the commission shall be appointed in a  
18 like manner and shall serve for only the unexpired term of the member who vacated. Members  
19 shall be eligible for reappointment. Any member may be removed by the governor for cause.  
20 Said commission shall meet quarterly or as need be if requested by 6 or more members of the  
21 commission.

22 The commission shall study and recommend options for updating farming technology  
23 including, but not limited to, ways to promote energy conservation, collaborative purchasing,  
24 purchasing and selling of energy, energy saving technology and alternative options for  
25 sustainability and growth. The commission shall, in the course of its study, analyze current  
26 regulations and statutes to ensure such regulations and statutes are not impediments to the  
27 adoption of farming technology.

28 The commission shall report to the governor and the general court the results of its  
29 investigation and study and its recommendations, if any, together with drafts of legislation  
30 necessary to carry its recommendations into effect by filing the same with the clerks of the house  
31 of representatives and the senate, who shall forward the same to the house and senate committees  
32 on ways and means and the joint committee on the environment, natural resources and  
33 agriculture on or before April 1, 2020, and annually thereafter.
