**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act exempting disabled veterans from sales tax when leasing a motor vehicle.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 6 of chapter 64H of the General Laws, as appearing in the 2014 Official Edition,
2 is hereby amended by striking out subsection (u) and inserting in place thereof the following
3 subsection:-

4 (u) Sale of a motor vehicle purchased by or leased to and for the use of a person who has
5 suffered loss, or permanent loss of use of, both legs or both arms or one leg and one arm or
6 purchased by or leased to and for the use of a veteran who has been determined to be
7 permanently disabled by the medical advisory board established pursuant to section 8C of
8 chapter 90 and has been issued a disabled veteran number plate pursuant to section 2 of said
9 chapter 90. This exemption shall apply to 1 motor vehicle only owned or leased and registered
10 for the personal, noncommercial use of such person.
