An Act relative to the enticement of children online.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 26C of chapter 265 of the General Laws, as appearing in the 2016  
2   Official Edition, is hereby amended, in line 2, by inserting after the word “invite” the following  
3   words:-- by any means, including but not limited to: personal contact, postal mail, telephone,  
4   instant electronic messaging and electronic mail.
