**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act relative to constables.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 10C of Chapter 21A of the General Laws is hereby amended by
2 deleting the words “and constables, except for the service of civil process” as they appear in lines
3 9 and 10.

4 SECTION 2. Section 10 of Chapter 22C of the General Laws is hereby amended by
5 deleting the words “constables, except the service of civil process, and of” and the words “and
6 watchmen” as they appear in lines 7 and 8.

7 SECTION 3. Section 54 of Chapter 22C of the General Laws is hereby amended by
8 deleting the word “Constables,” as it appears in line 1.

9 SECTION 4. Section 57 of Chapter 22C of the General Laws is hereby amended by
10 deleting the words “constables and” as they appear in line 14.

11 SECTION 5. Section 20 of Chapter 30A of the General Laws is hereby amended by
12 deleting the words “constable or other” as it appears in subsection (g), and inserting the word
13 “police” in place thereof.

14 SECTION 6. Section 13 of Chapter 34 of the General Laws is hereby amended by
15 deleting the words “or constables” as they appear in line 6.

16 SECTION 7. Section 13 of Chapter 34 of the General Laws is hereby amended by
17 inserting the word “or” before the words “a deputy sheriff”.

18 SECTION 8. Section 17 of Chapter 39 of the General Laws is hereby amended by
19 deleting the words “constable or any other person” as they appear in line 6, and inserting the
20 words “police officer” in place thereof.

21 SECTION 9. Section 37 of Chapter 40 of the General Laws is hereby amended by
22 deleting the word “constables” as it appears in line 2.

23 SECTION 10. Section 91B of Chapter 41 of the General Laws is hereby amended by
24 deleting the words “upon request give the appointing authority all possible assistance in making
25 such investigation.” as they appear in line 14, and inserting the following in place thereof:
26 “conduct a background investigation of the applicant, said investigation to include a review of
27 the applicant's criminal history, if any, to include a review of the applicant's criminal record in all
28 other states by the submission of a full set of the applicant's fingerprints pursuant to Sections
29 168, 172 and 28 U.S.C. Section 534. The Secretary of Public Safety shall have the authority to
30 promulgate regulations regarding constables.”

31 SECTION 11. Section 94 of Chapter 41 of the General Laws is hereby amended by
32 deleting the words “and warrants and processes in criminal cases, although their town, parish,
33 religious society or district is a party or interested. They shall have the powers of sheriffs to
34 require aid in the execution of their duties. They shall take due notice of and prosecute all
35 violations of law respecting the observance of the Lord's day, profane swearing and illegal
36 gaming.”

37 SECTION 12. Section 95 of Chapter 41 of the General Laws is hereby repealed in its
38 entirety.

39 SECTION 13. Section 98 of Chapter 41 of the General Laws is hereby amended by
40 deleting the words “shall have all the powers and duties of constables except serving and
41 executing civil process. They” as they appear in lines 2 and 3.

42 SECTION 14. Section 99 of Chapter 41 of the General Laws is hereby amended by
43 deleting the words “constables and” and the words “except as to the service of civil process,” as
44 they appear in lines 10 through 12.

45 SECTION 15. Section 101 of Chapter 41 of the General Laws is hereby amended by
46 deleting the words “constables and” as they appear in line 7.

47 SECTION 16. Section 25B of Chapter 54 of the General Laws is hereby amended by
48 deleting the words “or constables” as they appear in subsection (p).
