**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act expanding professional development for state university and community college campus police officers.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 116 of chapter 6 of the General Laws is hereby amended in paragraph 5 by
2 inserting after, "University of Massachusetts police officers" the following:- “and , state
3 university campus police officers and community college campus police officers and supervisors
4 of said employees who shall include police sergeants, lieutenants, captains, assistant chiefs,
5 deputy chiefs, and directors”
