*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:* 

### 1 Subdivision (1) of section 8 of chapter 32 of the General Laws, as appearing in the 2016

2 Official Edition, is amended in line 13, by striking the word "thereafter" and inserting in place

3 thereof the following words:- during the ten year period succeeding the date of retirement.
