**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act providing equitable access to behavioral health services for MassHealth consumers.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 12 of chapter 118E of the General Laws, as appearing in the 2016
2 Official Edition, is hereby amended by inserting at the end of the ninth paragraph the following:-

3 The Division shall certify and ensure that all contracted accountable care organizations,
4 contracted health insurers, health plans, health maintenance organizations, and behavioral health
5 management firms and third party administrators under contract to a Medicaid managed care
6 organization or primary care clinician plan provide comparable access to behavioral health
7 services, benefits, and medications in providing medical assistance to recipients.

8 The Division shall obtain the approval of the Secretary of the Executive Office of Health
9 and Human Services for all behavioral health services, benefits, and medications, including but

10 not limited to policies, protocols, standards, contract specifications, utilization review and
11 utilization management criteria and outcome measurements, used by all contracted accountable
12 care organizations, contracted insurers, health plans, health maintenance organizations,
13 behavioral health management firms and third party administrators under contract to a Medicaid
14 managed care organization or primary care clinician plan.
