An Act requiring school districts, with the assistance of the department of elementary and secondary education, to disclose information about required assessments.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 1I of Chapter 69 of the General Laws, as appearing in the 2016  
2 Official Edition, is hereby amended by adding the following two paragraphs at the end thereof: -

3 At the beginning of each school year, school districts must notify parents or guardians of  
4 enrolled students with the following information about each standardized assessment from  
5 kindergarten through twelfth grade that is required by the state or by the federal government:

- 6 (a) The subject areas covered by each assessment and what will be measured by each;
- 7 (b) When each standardized assessment will be administered;
- 8 (c) Whether each standardized test has been screened for bias;

- 9 (d) the estimated time a student will take to complete each standardized assessment;
- 10 (e) Whether students will be required to take standardized assessments online, or have the  
11 option of paper and pencil;
- 12 (f) Which assessments will be required for graduation and what options students have to  
13 meet graduation requirements if they do not pass a given assessment;
- 14 (g) How assessment results affect a student's high school and beyond plan and course-  
15 taking progression leading to timely graduation, as well as whether results of standardized  
16 assessments will be used for program placement or grade level advancement;
- 17 (h) When the assessment results will be released to parents or guardians and whether  
18 there will be an opportunity for parents and teachers to discuss strategic instructional  
19 adjustments;
- 20 (i) The process, forms, and time necessary to access individual students' tests;
- 21 (j) How the assessment and assessment results will advance student learning;
- 22 (k) How much instructional time and specialists' time will be in spent in administering  
23 assessments;
- 24 (l) The financial cost to both the school district and Commonwealth of administering the  
25 assessment;
- 26 (m) Whether the assessment is required by the Commonwealth, by the federal  
27 government, or by both; and,

28           (n) The availability of appropriate accommodations for students with disabilities and  
29 English language learners, which shall be translated for non-English speaking parents into their  
30 preferred language.

31           The department of elementary and secondary education shall provide to school districts  
32 regularly updated information necessary for districts to notify parents of the information under  
33 this section, including any changes occurring through regulatory, legislative or federal action,  
34 that will affect current or future assessments; further, the department shall provide templates and  
35 any other assistance necessary to notify parents on a timely basis; provided, further, the  
36 department shall institute a grant program for school districts to pay any costs associated with  
37 preparing, printing or distributing information to parents, as required by this section, and funding  
38 for said grant program and any other costs to the department shall come from the funding  
39 allocated for the administration of the state assessment system.
