**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-First General Court  
(2019-2020)**

An Act authorizing the town of Medfield to enter into a long-term lease for an arts and cultural center.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Notwithstanding section 3 of chapter 40 of the General Laws, or any other  
2 general or special law to the contrary, the town of Medfield, acting by and through its board of  
3 selectmen, is hereby authorized to lease a portion of town-owned land at the former Medfield  
4 State Hospital, consisting of the 2 buildings formerly known as Lee Chapel and the Infirmary  
5 Building, together with the surrounding land, to a public or private entity for up to 99 years, upon  
6 such terms and conditions as the board of selectmen determine to be in the town's interests, for  
7 the purpose of developing and operating an arts and cultural center.

8 SECTION 2. Notwithstanding section 16 of chapter 30B of the General Laws, or any  
9 other general or special law to the contrary, the town of Medfield, acting by and through its  
10 board of selectmen, is hereby authorized to enter into a lease, as authorized by section 1, with  
11 Cultural Alliance of Medfield, Inc., a duly-organized Massachusetts non-profit corporation.

SECTION 3. This act shall take effect upon its passage.
