An Act relative to the civil service hiring of surviving dependents.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Section 1. Said section 26 of Chapter 31 of the General Laws is hereby amended in the  
2   seventh paragraph of said section by inserting in subsection (ii), after the word "person", the  
3   following:- "or as the result of an motor vehicle crash while on duty and operating a department  
4   vehicle,"
