



Letter from the Executive Director

In 2019, Charitable Gaming licensees throughout the Commonwealth reported a total of \$55.9 million in gross revenues, comprised of \$22.2 million from Beano games; \$12.2 million from charity game ticket sales; \$21.4 million from raffles and \$80,256 from bazaars (Las Vegas nights).

Proceeds generated from Beano games have touched the lives of many citizens across the Commonwealth by providing funds for many charitable causes. Students have received scholarships; needy families received holiday food and gift baskets; senior citizens celebrated the holidays; and many youth sports programs were supported. Veterans were remembered and celebrated at various V.A. hospitals, and in parades commemorating Memorial Day and Veterans' Day.

Bingo provides an important social component to our citizens, while providing revenue to the state's many charitable causes. The Lottery will strive to enable Bingo and all charitable gaming to continue to operate in the Commonwealth and bring assistance to its citizens.

As always, I would like to thank all of the dedicated volunteers and patrons throughout the Commonwealth who have contributed to the success of Charitable Gaming in 2019. Their tireless commitment and devotion has helped ease some of the financial burden faced by countless charitable organizations across Massachusetts.





History of Legislative Authority

Bingo (Beano) was legalized in the Commonwealth of Massachusetts on September 29, 1971. Effective September 4, 1973, Chapter 729 of the Acts of 1973 transferred responsibility for control of the operation of Bingo from the Massachusetts Department of Public Safety to the Massachusetts State Lottery Commission. By authority conferred in Section 38 of Chapter 10 of the General Laws, Rules and Regulations controlling Bingo were adopted on March 1, 1974 and amended in October 1974, July 1980, November 1991, March 1994 and October, 2000.

Effective January 1, 1978, Chapter 219 of the Acts of 1977 transferred responsibility for col-lection of the five percent Bingo and Raffle/Bazaar (Casino Functions) Tax from the Department of Revenue to the Massachusetts State Lottery Commission. By authority con-ferred in Section 39A of Chapter 10 of the General Laws, Rules and Regulations Controlling Certain Raffle and Bazaar Permits were adopted earlier and amended in December 1980.

Senior Citizens' Recreational Bingo

Effective March 16, 1984, Chapter 619, Acts of 1983 allowed for the conduct of Recreational Bingo at Senior Citizens' or Golden Age Clubs for the recreation of members. This law requires said organizations apply for an identification number from the Massachusetts State Lottery Commission.

During 2019, the Massachusetts State Lottery Commission had on file 272 identification numbers issued for Senior Citizens' Recreational Bingo. Qualified organizations are provided certificates at no cost.
