An Act relative to Department of Developmental Services' employee retirement classification.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. Section 3 of chapter 32 of the General Laws as appearing in the 2006 Official
- 2 Edition is hereby amended by inserting after the word prisoners in line 252 the following words:-
- 3 employees of the Department of Developmental Services holding the positions of HSC A/B,
- 4 HSC C, HSC D, employed in such capacities or other DDS Group 2 titles for 10 years of more.
