An Act to restrict the use of polystyrene.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 111 of the General Laws, as appearing in the 2016 Official Edition, is hereby  
2 amended by inserting after section 5S, the following section:-

3 Section 5T. (a) For the purposes of this section, the following terms shall have the  
4 following meanings unless the context clearly requires otherwise:

5 “Disposable Food Container” a single-use disposable product used in a food service  
6 establishment for serving, transporting, or packaging prepared, ready-to-consume, or uncooked  
7 food or beverages,

8           “Food Establishment” a business that stores, prepares, packages, serves, vends, or  
9 otherwise provides food for human consumption, including but not limited to any establishment  
10 requiring a permit to operate in accordance with the State Food Code.

11           “Polystyrene” a synthetic resin which is a polymer of styrene, used chiefly as lightweight  
12 rigid foams and solid containers.

13           “Prepared Food” food or beverage for consumption on the premises of a food  
14 establishment, using any cooking or food preparation technique. This does not include any raw  
15 uncooked meat, fish or eggs unless provided for consumption without further food preparation.

16           “Retail Establishment” a commercial business facility that sells goods directly to the  
17 consumer including but not limited to grocery stores, pharmacies, liquor stores, convenience  
18 stores, restaurants, retail stores and vendors selling clothing, food, and personal items

19           (b) Except as provided herein, on or after August 1, 2020, food establishments shall be  
20 prohibited from dispensing food to customers in disposable food service containers made from  
21 polystyrene.

22           (c) Except as provided herein, on and after August 1, 2020, retail establishments shall be  
23 prohibited from selling or distributing disposable food containers made of polystyrene to  
24 customers.

25           (d) A food establishment may apply to the health department of the town or city in which  
26 it operates, showing that the conditions of this provision would cause undue hardship. The local  
27 health department or its designee may defer application of this provision for a food establishment  
28 for a one year period. An undue hardship shall mean a situation unique to the food establishment

29 where there are no reasonable alternatives to the use of polystyrene disposable food service  
30 containers and compliance with this provision would cause significant economic hardship to that  
31 food establishment.

32 (e) The commissioner shall promulgate regulations for the enforcement of this section.  
33 Regulations promulgated under this section shall include fines, not to exceed one thousand  
34 dollars, for any single violation of subsections (b) and (c).
