An Act to require liability insurance for gun ownership.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 140 of the General Laws is hereby amended by adding the  
2 following section:-

3 Section 207. (a) Any person who possesses, carries, or owns a firearm, rifle or shotgun  
4 shall obtain and maintain a liability policy, bond, or deposit. This section shall not apply to a  
5 person who possesses a firearm, rifle, or shotgun on a temporary basis while on the premises of a  
6 licensed gun club. Violation of this section shall result in a punishment of a fine of not less than  
7 five hundred and not more than five thousand dollars, or by imprisonment for not more than one  
8 year in a house of correction, or both.

9 (b) The commissioner of insurance shall promulgate regulations set forth for the  
10 minimum terms of liability insurance policies which shall satisfy the requirements of this section.
