An Act relative to surviving family members of public emergency medical technicians.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 100 of chapter 32 of the General Laws, as appearing in the 2016  
2 Official Edition, is hereby amended by inserting after the word “death,” in line 15 the following  
3 words:-

4           or if a public emergency medical technician while in the performance of his duties and as  
5 the result of an assault on his person or as a result of an accident while responding to or returning  
6 from any emergency or as the result of an accident involving an EMS department vehicle, which  
7 the public emergency medical technician is operating or in which he is riding or while at the  
8 scene of any emergency is killed or sustains injuries while on duty which results in his death,
