By Ms. Gobi, a petition (accompanied by bill, Senate, No. 1670) of Anne M. Gobi, Joseph D. McKenna, Todd M. Smola, Dean A. Tran and other members of the General Court for legislation to establish the Snowmobile Trail Maintenance Fund. Revenue.

An Act establishing the Snowmobile Trail Maintenance Fund.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1.	Chapter 29 of the	General Laws.	as appearing in th	ne 2016 Official Edition,

2 is hereby amended by inserting after section 2RRRR the following section:-

3 Section 2XXX. There shall be established and set upon the books of the commonwealth a 4 separate fund to be known as the Snowmobile Trail Maintenance Fund, the funds of which shall 5 be administered and expended by the Secretary of the Executive Office of Energy and 6 Environmental Affairs for the grooming, maintaining, and repairing of publicly-owned trails 7 marked and designated for use by snow vehicles as defined in section 20 of Chapter 90B. The 8 Secretary of the Executive Office of Energy and Environmental Affairs shall contract with an 9 organization promoting snowmobile safety and working toward the development, maintenance, 10 and expansion of an interconnected snowmobile trail system throughout Massachusetts to 11 expend these funds, provided that revenues retained not exceeding 5 per cent be expended by the 12 Secretary for law enforcement and administrative costs associated with the administration and

13 implementation of this fund. Said contract shall be issued annually, and at a time of year to be 14 determined by Secretary of the Executive Office of Energy and Environmental Affairs 15 The Secretary of the Executive Office of Energy and Environmental Affairs shall report 16 annually to the house and senate committees on ways and means and the joint committee on 17 environment, natural resources and agriculture on income received into the fund and sources of 18 that income, any expenditure from the fund and their purposes, and fund balances. 19 The Snowmobile Trail Maintenance Fund may receive monies from: (1) gifts, grants and 20 donations from public or private sources; (2) federal reimbursements and grants-in-aid; (3) fines 21 collected pursuant to section 27F of Chapter 90B; and (4) any interest earned from the fund. The 22 state treasurer shall receive, deposit and invest funds held in such a manner as to ensure the 23 highest interest rate available consistent with the safety of the fund. The books and records of the 24 fund shall be subject to an annual audit by the state auditor. The Secretary of the Executive 25 Office of Energy and Environmental Affairs may expend such funds and no expenditure from the 26 fund shall cause it to be in deficiency at the close of a fiscal year. Monies deposited in the fund 27 that are unexpended at the end of the fiscal year shall not revert to the General Fund and shall be 28 available for expenditure in the subsequent year and shall not be subject to section 5C of chapter 29 29.
