**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act relative to regional tourism councils.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 23A is hereby amended by adding the following new section:-

2 Section 68. Grants allocated to regional tourism councils through the Massachusetts

3 Tourism Trust Fund established in section 13T in chapter 23A shall be distributed not later than

4 September 1 of the fiscal year for which they are allocated.
