In the One Hundred and Ninety-First General Court (2019-2020)

An Act relative to school bus driver licensing.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:* 

1 SECTION 1. Section 8A <sup>1</sup>/<sub>2</sub> of Chapter 90 of the General Laws, as appearing the 2016

2 Official Edition, is hereby amended in line 16 by inserting after the word "registrar" the

3 following:- "provided, however, that such person is determined to have a clean driving record at

4 the time of application, as outlined in this section".

5 SECTION 2. Said section 8A <sup>1</sup>/<sub>2</sub> of said Chapter 90, as so appearing, is hereby amended

6 in line 54 by inserting after the word "section." the following:- The registrar shall develop and

7 promulgate an automatic reporting system for school bus drivers arrested for non-traffic

8 violations.

9 SECTION 3. Said section 8A ½ of said Chapter 90, as so appearing, is hereby amended
10 by inserting after the first paragraph the following paragraph:

11	For the purposes of this section, a person shall be determined to have a clean driving
12	record if the person has:

- 13 (1) no traffic violations in the previous year;
- 14 (2) no major traffic violations, as defined in 211 CMR 134.10(3)(c), in the previous 5
- 15 years, and not more than 3 such violations in the applicant's driving history;
- 16 (3) not more than 5 minor traffic violations, as defined in 211 CMR 134.10(3)(d), in the
  17 previous 5 years; and
- 18 (4) not more than 3 at-fault accidents in the previous 5 years.
