## The Commonwealth of Alassachusetts

In the One Hundred and Ninety-First General Court (2019-2020)

An Act to invest more in middle class jobs and less in the relocation of out-of-state corporations.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 63 of chapter 23A, as so amended in chapter 228 of the acts of
- 2 2018, is hereby amended by inserting at the end thereof the following subsection:-
- 3 "(h) Any grants over \$20 million issued under this section to municipalities or other
- 4 public instrumentalities used to incentivize corporations to relocate to the commonwealth that
- 5 have been rescinded due to non-compliance with the terms of said grant issuance shall be
- 6 redirected and awarded to vocational schools and school districts that include one or more
- 7 vocational schools to fund the design, construction, and renovation of said vocational schools
- 8 and equipment purchases and installation for vocational-technical education programs, as
- 9 defined in section 1 of chapter 74 of the general laws, in order to improve and augment said
- 10 programs and to reduce student waitlists at said vocational schools."
