An Act relative to economic mobility for families with low-income.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 18 of the General Laws is hereby amended by inserting after  
2 section 39 the following section:-

3           Section 40. (a) The department of transitional assistance shall establish a telephone  
4 hotline for citizens to have the ability to get advice on program benefits, program eligibility,  
5 application processes and intersectionality with other programs facilitated by agencies other than  
6 the department of transitional assistance, including but not limited to the executive office of  
7 housing and economic development, the executive office of labor and workforce development,  
8 and the executive office of education.

9           (b) There shall be a benefits calculator for use by the public through a website with  
10 instructions for the public.

11           (c) Information about the hotline and benefits calculator including the phone number  
12 shall be posted on    the executive office of health and human services, executive office of  
13 housing and economic development, executive office of labor and workforce development

14 office's websites, and be made available to homeless service providers in a form appropriate for  
15 distribution to their clients.

16 (d) The department of transitional assistance shall provide training for calculating  
17 benefits using a benefits calculator in order to optimize benefits to avoid cliff effects to executive  
18 offices and agencies involved in distributing benefits programs.

19 SECTION 2. (a) The executive office of health and human services, the department of  
20 transitional assistance, executive office of housing and economic development, executive office  
21 of labor and workforce development and executive office of education shall file an annual report  
22 based on data from the previous fiscal year for the purposes of gaining a deeper understanding of  
23 housing instability faced by families in order to efficiently predict and better direct homelessness  
24 prevention and housing resources. The report shall include the following metrics:

25 (1) The number of client households that have been identified as homeless and at risk of  
26 homelessness by each agency; (2) The numbers of households receiving Emergency Assistance  
27 Shelter also receiving benefits and services from the following: (i) Department of Transitional  
28 Assistance – Supplemental Nutrition Assistance Program and Transitional Aid for Families with  
29 Dependent Children; (ii) Workforce Development Programs; (iii) Department of Children and  
30 Families; (iv) Department of Public Health - Early Intervention Services (v) MassHealth; and (vi)  
31 income sources for families in shelter; (3) MassHealth data on housing instability screening for  
32 patients; (4) The stability of households that have received assistance from the HomeBASE  
33 program, including, the number of households that have received assistance from the  
34 HomeBASE program under line-item 7004-0108, the numbers of households that were evicted,  
35 the numbers that returned to shelter, number of households with DCF involvement, numbers

36 with incomes below 150% of the Federal Poverty Level. The Department shall coordinate with  
37 programs under the Executive Office of Health and Human Services on matching data sets for  
38 the purposes of this report; (5) The number of contracted slots for homeless children and the  
39 current utilization, the number of childcare vouchers issued to homelessness households based  
40 off of data from the Department of Early Education and Care; and (6) The cross agency working  
41 groups and committees relative to homelessness, that are currently active at the state agencies,  
42 will submit their reports and finding on housing stability and economic mobility.

43 (b) The report shall be submitted to the clerks of the house and the senate, the house and  
44 senate committees on ways and means, the joint committee on children families and persons with  
45 disabilities, the joint committee on labor and workforce development and the interagency council  
46 on housing and homelessness no later than October 31 of each year.

47 SECTION 3. The executive office of administration and finance in conjunction with the  
48 executive office of health and human services, the department of transitional assistance, the  
49 executive office of housing and economic development, the executive office of labor and  
50 workforce development and the executive office of education shall conduct and publish an  
51 impact study report on the impacts of minimum wage increase as directed in the chapter 121 of  
52 the acts of 2018 on households with low incomes who would lose the eligibility of benefits due  
53 to the wage increase with decline in net resources and face cliff effects. The impact study shall  
54 also recommend directives to determine ways to adjust assistance in response to changes in  
55 income, including but not limited to automatic adjustments tied to minimum wage increases and  
56 options for increasing utilization of the earned income tax credit in order to prevent families  
57 from facing cliff effects. The report shall be submitted to the clerks of the house and the senate,  
58 the house and senate committees on ways and means, the joint committee on children families

59 and persons with disabilities, the joint committee on labor and workforce development and the  
60 interagency council on housing and homelessness no later than January 1, 2022.

61 SECTION 4. The executive office of health and human services, the department of  
62 transitional assistance, executive office of housing and economic development, executive office  
63 of labor and workforce development and executive office of education shall examine economic  
64 mobility programs, recommend criteria for evaluation and create a mechanism for evaluating  
65 economic mobility programs for program outcomes including changes in earned income,  
66 education and state and federally funded services and the feedback of participants and those not  
67 enrolled in programs, for the purpose of producing a report. The report shall recommend  
68 directives for each executive office to expand outreach to eligible non-participants to boost  
69 enrollment. The report shall outline the outcomes for economic mobility and financial stability  
70 programs for families and individuals with extremely low incomes, as defined by the United  
71 States Department of Housing and Urban Development. The report shall be submitted to the  
72 clerks of the house and the senate, the house and senate committees on ways and means, the joint  
73 committee on children families and persons with disabilities, the joint committee on labor and  
74 workforce development and the interagency council on housing and homelessness no later than  
75 January 1, 2022.

76 SECTION 5. Section 2 is hereby repealed.

77 SECTION 6. Section 5 shall take effect on December 31, 2027.
