| 1 | WHEREAS, The outbreak of the 2019 novel coronavirus, also known as COVID-19, and |

| 5 | WHEREAS, In light of the guidance of medical professionals, the governor and other |
| 6 | governmental officials and in order to provide for the public safety, including the safety of |
| 7 | members and staff, additional methods of voting and participation are necessary; and |

| 9 | WHEREAS, The Senate, pursuant to Article VII of Section II of Chapter I of Part the |
| 10 | Second of the Constitution of the Commonwealth, has the power to determine its own rules of |
| 11 | proceedings; now, therefore be it |

| 13 | ORDERED, That the Senate declares that a state of emergency continues to exist within |
| 14 | the Senate as a result of the outbreak of COVID-19; and be it further |

| 16 | ORDERED, That the following provisions shall apply for the Senate for actions taken in |
| 17 | formal sessions: |

| 19 | Section 1. (a) Notwithstanding Senate Rule 55, Senate Rule 57 or any other rule to the |
| 20 | contrary, a member may authorize the presiding officer to announce the member's vote or record |
| 21 | the member's presence in the Senate. |

23 (b) A member may authorize the presiding officer by submitting a letter to the Clerk that 24 specifies the member's exact instruction to the presiding officer on how to answer the question for which the roll call is ordered and states that the presiding officer is authorized to announce 25 the member's vote or record the member's presence; provided, however, that a member may 26 27 alter or revoke this authorization by submitting a letter to the Clerk; provided further, that if a 28 member who has so authorized the presiding officer casts the member's own vote or records the 29 member's own presence, the member shall be considered to have revoked the authorization to 30 announce the member's vote or record the member's presence in the Senate. Upon receipt of a 31 member's letter authorizing the presiding officer or altering or revoking the authorization of the 32 presiding officer, the Clerk shall notify the President and the minority leader of the authorization, 33 alteration or revocation. The Clerk shall maintain an updated list of the authorizations, alterations 34 and revocations submitted or in effect under this order and shall make the list publicly available 35 in electronic form and available during any vote subject to this order. 36

(c) The presiding officer shall answer the roll call on behalf of each member who has
authorized the presiding officer to announce the vote or record the presence of the member;
provided, however, that the presiding officer shall announce the vote or record the presence in
accordance with the member's exact instruction.

(d) A letter under this section may be submitted to the Clerk electronically.

44 Section 2. Notwithstanding Senate Rule 57 or any other rule to the contrary, a member 45 may be excused from voting personally in the Senate Chamber due to the risk of exposure to COVID-19 and may record the member's vote on a question for which a roll call has been 46 47 ordered, record the member's presence or be counted on any procedural question remotely. The President shall establish and provide members access to a telephone line or other electronic 48 49 means to record their vote or presence or to be counted, which shall be monitored by a court 50 officer and a member of the Clerk's staff. A court officer shall ascertain and announce any such 51 recordation on behalf of the member and a member of the Clerk's office shall verify the account. 52 53 Section 3. A member who participates remotely pursuant to section 1 or section 2 shall be

Section 3. A member who participates remotely pursuant to section 1 or section 2 shall be
 counted for the purpose of establishing a quorum as required pursuant to Senate Rule 64 and
 Article XXXIII of the Amendments to the Constitution of the Commonwealth.

57 Section 4. No person shall be permitted in the Senate Chamber, the Senate Reading room, 58 the cloak room or the anterooms without an appropriate mask or other face covering that covers 59 the person's nose and mouth. The mask or other face covering shall cover the person's nose and 60 mouth at all times while in the Senate Chamber, the Senate Reading room, the cloak room or the 61 anterooms.

63 Section 5. The presiding officer shall ensure that, while in the Senate Chamber, the
 64 Senate Reading room, the cloak room or the anterooms, members and staff maintain appropriate
 65 social distancing.

67 Section 6. Notwithstanding Senate Rule 39, Senate Rule 57 or any other rule to the 68 contrary, a member may deliver remarks in the chamber not from the member's designated place and may vote from the chamber not from the member's assigned seat; provided, however, that all 69 70 members aside from the President or presiding officer, the chair of the senate committee on ways 71 and means, the minority leader and any additional members designated by the President as 72 necessary to facilitate the efficient operation of the session, including, but not limited to, a chair 73 of relevant jurisdiction, shall be encouraged to participate remotely in session pursuant to section 74 1 or section 2 and refrain from entering the chamber except to deliver in-person remarks; provided further, that such a member, prior to entering the Senate Chamber to deliver in-person 75 remarks, shall, to the extent feasible, coordinate such delivery of remarks by contacting a 76 77 staffperson designated by the President. The staffperson shall maintain a list of members who 78 would like to deliver remarks in the Senate Chamber and shall, to the extent feasible, post or 79 otherwise make available to members such list. 80

81 Section 7. Only staff necessary to administer the session, including the court officers, the
82 President's staff, the staff of the senate counsel, the staff of the Clerk, the minority leader's staff,
83 the staff of the senate committee on ways and means and other staff as identified by the
84 President, shall be permitted in the Senate Chamber.

85

86 Section 8. The President shall, to the extent feasible, provide members access to a 87 telephone line or other electronic means to allow them to speak in session and shall designate an 88 appropriate staffperson to coordinate participation in debate by any member who would like to 89 speak from outside the chamber. The staffperson shall maintain a list of members who would 90 like to speak for the presiding officer to recognize at the appropriate time. The list shall, to the 91 extent feasible, be posted or otherwise made known to members.

93 Section 9. The presiding officer shall endeavor to ensure that the Senate's proceedings 94 account for any delay or lag time that occurs due to the remote participation of members in the 95 session. The session shall be conducted at a pace that provides adequate timing and intervals to 96 allow for effective spontaneous responses by the members.
