1 SECTION 1. To provide for a program of capital investments for public safety,
2 governmental infrastructure, information technology and data and cyber-security improvements
3 to various state programs, services, agencies, institutions and properties and to fund technology
4 infrastructure, the sums set forth in this act, for the several purposes and subject to the conditions
5 specified in this act, are hereby made available, subject to the laws regulating the disbursement
6 of public funds, which sums shall be in addition to any other amounts previously appropriated
7 for these purposes; provided, that the amounts specified for a particular project may be adjusted
8 in order to facilitate projects authorized in this act.

363 \$45,000,000. All such bonds issued by the commonwealth shall be designated on their face,
364 General Governmental Infrastructure Act of 2020, and shall be issued for a maximum term of
365 years, not exceeding 10 years, as the governor may recommend to the general court under
366 section 3 of Article LXII of the Amendments to the Constitution. The bonds shall be payable not
367 later than June 30, 2035. All interest and payments on account of principal on these obligations
368 shall be payable from the General Fund. Bonds and interest thereon issued under this section

369 shall, notwithstanding any other provision of this act, be general obligations of the
370 commonwealth.

371 SECTION 12. To meet the expenditures necessary in carrying out section 2E, the state
372 treasurer shall, upon request of the governor, issue and sell bonds of the commonwealth in an
373 amount to be specified by the governor from time to time but not exceeding, in the aggregate,
374 \$124,050,000. All such bonds issued by the commonwealth shall be designated on their face,
375 General Governmental Infrastructure Act of 2020, and shall be issued for a maximum term of
376 years, not exceeding 7 years, as the governor may recommend to the general court under section
377 3 of Article LXII of the Amendments to the Constitution. The bonds shall be payable not later
378 than June 30, 2032. All interest and payments on account of principal on these obligations shall
379 be payable from the General Fund. Bonds and interest thereon issued under this section shall,
380 notwithstanding any other provision of this act, be general obligations of the commonwealth.

381 SECTION 13. To meet the expenditures necessary in carrying out section 2F, the state
382 treasurer shall, upon request of the governor, issue and sell bonds of the commonwealth in an
383 amount to be specified by the governor from time to time but not exceeding, in the aggregate,
384 \$41,500,000. All such bonds issued by the commonwealth shall be designated on their face,
385 General Governmental Infrastructure Act of 2020, and shall be issued for a maximum term of
386 years, not exceeding 20 years, as the governor may recommend to the general court under
387 section 3 of Article LXII of the Amendments to the Constitution. The bonds shall be payable not
388 later than June 30, 2045. All interest and payments on account of principal on these obligations
389 shall be payable from the General Fund. Bonds and interest thereon issued under this section
390 shall, notwithstanding any other provision of this act, be general obligations of the
391 commonwealth.

392 SECTION 14. To provide for the continued availability of certain bond-funded spending
393 authorizations which otherwise would expire, the balances of the following appropriation items
394 and any allocations thereof are hereby extended through June 30, 2024 for the purposes of and
395 subject to the conditions stated for these items in the original authorizations and any amendments
396 to such authorizations: 0640-0035, 1100-9200, 1599-7061, 1790-3001, 1790-3002, 1790-3003,
397 7000-9091 and 8100-2026.
