**In the One Hundred and Ninety-First General Court  
(2019-2020)**

An Act relative to the financial impact of charter schools.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 89 of said chapter 71, as appearing in the 2016 Official Edition, is  
2 hereby amended by inserting after the word “application”, in line 294, the following words:-  
3 including, but not limited to the financial impact of establishing or expanding the charter school  
4 on the students and schools of the sending district or districts

5 SECTION 2. Section 89 of said chapter 71, as so appearing, is hereby amended by  
6 inserting after the word “criteria”, in line 296, the following text:- No charter application shall be  
7 approved before a report has been presented to the board by the department on the financial  
8 impact to the sending district or districts.

9 SECTION 3. Subsection (gg) of said section 89 of said chapter 71, as so appearing, is  
10 hereby amended by adding the following 2 sentences:- Annually, not later than January 10, the  
11 department shall make a request to the general court for the full funding of this reimbursement  
12 and the reimbursement calculated under subsection (ff). If the general court rejects the request to

- 13 fund the reimbursement, the board shall not approve any application for a new charter school or
- 14 a charter school expansion in the following school year.
