An Act to ensure higher education student and campus safety.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. To provide for a program of capital improvements to public institutions of
2	higher education to ensure the well-being and safety of students, faculty, staff and the college
3	community at large, support their educational missions, and enhance regional economic
4	development through their educational initiatives, the sums set forth in section 2, for the several
5	purposes and subject to the conditions specified in this act, are hereby made available, subject to
6	the laws regulating the disbursement of public funds, which sums shall be in addition to any
7	other amounts previously appropriated for these purposes.
8	SECTION 2.

18	SECTION 3. To meet the expenditures necessary in carrying out section 2, the state
19	treasurer shall, upon request of the governor, issue and sell bonds of the Commonwealth in an
20	amount to be specified by the governor from time to time but not exceeding, in the aggregate,
21	\$115,000,000. All bonds issued by the Commonwealth as aforesaid shall be designated on their
22	face, Public Higher Education Campus Safety Expenditure Act of 2019, and shall be issued for a
23	maximum term of years, not exceeding 30 years, as the governor may recommend to the general
24	court under section 3 of Article LXII of the Amendments to the Constitution. The bonds shall be
25	payable not later than June 30, 2059. All interest and payments on account of principal on these
26	obligations shall be payable from the General Fund. Bonds and interest on bonds issued under
27	this section shall, notwithstanding any other provision of this act, be general obligations of the
28	commonwealth.
29	SECTION 4. Section 2 of Chapter 154 of the Acts of 2018, is hereby amended by adding
30	the following item:

SECTION 5. The secretary of administration and finance shall submit a report on the 33 progress and all expenditures related to any projects funded through the authorizations in Section 34 2 of this act to the secretary of education, the board of higher education, the chairs of the senate 35 36 and house committees on ways and means, the senate and house chairs of the joint committee on 37 higher education, and the chairs of the committees on Bonding, Capital Expenditures and State 38 Assets. The report shall include, but not be limited to: the total amount appropriated for each 39 project; the total estimated cost of each project; the amount expended on each project up to the 40 time the report is filed; the total amount currently expended on each project. The report shall be 41 submitted on December 31 of each year for a period of 10 years from the effective date of this 42 act.
