An Act strengthening the penalty for assault or assault and battery on emergency medical technician, ambulance operator, ambulance attendant or health care provider.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 13I of Chapter 265 of the General Laws as appearing in the 2016  
2 Official Edition, is hereby amended by striking out, in line 4, the words "treating or transporting  
3 a person".

4 SECTION 2. Section 13I of Chapter 265 of the General Laws as appearing in the 2016  
5 Official Edition, is hereby amended by striking out, in lines 5 and 6, the words "house of  
6 correction for not less than 90 days nor more than 2 and one-half years or by a fine of not less  
7 than \$500 nor more than \$5,000, or both." and inserting in place thereof the following words:  
8 state prison for not more than five years, or by imprisonment in a jail or house of correction for  
9 not more than two and one-half years.
