An Act relative to the mandated reporter law.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 51A of chapter 119 of the General Laws, as most recently amended  
2 by section 10 of chapter 178 of the acts of 2011, is hereby further amended by striking out the  
3 first paragraph and inserting in place thereof the following paragraph:-

4 (a) A mandated reporter who, in his or her professional capacity, has reasonable  
5 cause to believe that a child is suffering physical or emotional injury resulting from: (i) abuse  
6 inflicted upon him which causes harm or substantial risk of harm to the child's health or welfare,  
7 including sexual abuse; (ii) neglect, including malnutrition; (iii) physical dependence upon an  
8 addictive drug at birth, (iv) being a sexually exploited child; or (v) being a human trafficking  
9 victim as defined by section 20M of chapter 233, shall immediately communicate with the  
10 department orally and, within 48 hours, shall file a written report with the department detailing

11 the suspected abuse or neglect. A mandated reporter who, in his or her professional capacity,  
12 becomes aware of a sexually exploitative relationship between a child under the age of 18 and  
13 another mandated reporter, shall immediately communicate with the department orally and,  
14 within 48 hours, shall file a written report with the department detailing the suspected  
15 exploitation.
