An Act relative to survivor retirement benefits.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding the provisions of any general or special law to the
2 contrary, Chapter 32 Section 94B(2) of the General Laws as appearing in the 2014 Official
3 Edition is hereby amended by striking the word "five" in line 27 and inserting the word "ten"
4 after the word "within" in line 27.

5 SECTION 2. Chapter 32 Section 94B (2) of the General Laws as appearing in the 2014
6 Official Edition is hereby amended by inserting in line 31 after the word "compensation" the
7 following words," in the event that such person retires in accordance with this section any
8 secondary cancer shall be covered in accordance with section 9 of this chapter."
