The Commonwealth of Massachusetts

In the One Hundred and Ninety-First General Court
(2019-2020)

An Act relative to increasing the civil fines and financial responsibilities and criminal penalties of motorists who violate the right of way of other motorists, motorcyclists, bicyclists and/or pedestrians, resulting in serious bodily injury and/or death.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 8 of chapter 89 of the General Laws is hereby amended by striking
2 out, in line 31, the word “thirty-five” and replacing it with the words “two hundred.”

3 SECTION 2. Section 8 of said chapter 89 of the General Laws is hereby further amended
4 by adding at the end of said section the following new paragraph:-

5 “Any person who is found guilty of or pleads guilty or nolo contendere to a violation of
6 the provisions of this section shall be subject to the following penalties:

7 (a) If the violation results in the injury of another person, the offender shall, in addition to
8 any other penalties, be fined two hundred dollars and have their driver's or commercial driver's
9 license or permit or nonresident operating privilege suspended for a period of not less than thirty
10 days, or both.

11 (b) If the violation results in the serious bodily injury of another person, the offender
12 shall, in addition to any other penalties, be fined five hundred dollars and have their driver's or
13 commercial driver's license or permit or nonresident operating privilege suspended for a period
14 of not less than ninety days, or both.

15 (c) If the violation results in the death of another person, the offender shall, in addition to
16 any other penalties, be fined one thousand dollars and have their driver's or commercial driver's
17 license or permit or nonresident operating privilege suspended for a period of not less than one
18 hundred eighty days, or both.

19 (d) For purposes of this section, "serious bodily injury" shall mean a bodily injury which
20 involves unconsciousness, extreme physical pain, or protracted and obvious disfigurement,
21 protracted loss or impairment of the function of a bodily member, organ, or mental faculty, or a
22 substantial risk of death."
