An Act allowing spouses as caregivers.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 9 of chapter 118E of the General Laws, as appearing in the 2018  
2 Official Edition, is hereby amended by inserting in line 16, after the words "requirements of Title  
3 XIX;", the following words:-

4 provided further, that spouses shall be permitted to serve as caregivers in the adult foster  
5 care and personal care attendant programs.
