Resolve establishing a special commission to review advancements in educational technology, digital/online learning and related programs.

1           **Resolved**, establishing a special commission to review advancements in educational  
2 technology, digital/online learning and related programs in order to provide the Administration,  
3 the Legislature, Municipalities and all other interested parties with the most current research and  
4 information concerning educational technology and content to assess the feasibility of state,  
5 local and private educational systems adopting, implementing or integrating current technology  
6 to enhance and improve the educational experience for students and educational professionals  
7 while reducing costs for the citizens of the Commonwealth.

8           WHEREAS there have been exceptional advancements and innovation with educational  
9 technology in recent years, and

10           WHEREAS the current pandemic has demonstrated the need to upgrade the methodology  
11 of providing educational instruction and innovation to insure that our citizens and educational  
12 professionals are properly served, and

13           WHEREAS it is necessary that our public officials and educational professionals to have  
14 the best possible information about the available resources to adequately provide educational  
15 opportunities for all of their constituents and particularly the underserved populations. It is  
16 hereby

17           Resolved, that a special commission be established to review advancements in  
18 educational technology, digital/online learning and related programs in order to provide the  
19 Administration, the Legislature, Municipalities and all other interested parties with the most  
20 current research and information concerning educational technology and content to assess the  
21 feasibility of state, local and private educational systems adopting, implementing or integrating  
22 improved technology to enhance the educational experience for students and educational  
23 professionals and reduce costs for the citizens of the Commonwealth.

24           The commission shall consist of 9 members as follows: the secretary of technology  
25 services and security, the chairman of the board of higher education, the chair of the board of  
26 elementary and secondary education, or their designee(s) and 6 members appointed by the  
27 governor: one of whom shall represent either umass online or mass colleges online, one of whom  
28 shall be from the Association of Independent Colleges and Universities in Massachusetts, two of  
29 whom shall be representatives of digital learning technology and content companies , two of  
30 whom shall be a representatives of U.S. -based, large technology companies with a significant  
31 component in educational technology who have a business presence in the Commonwealth.

32           In addition to an analysis of the technology the commission shall address issues such as  
33 improving access to underserved populations,public/private partnerships, cost containment and  
34 the integration of educational technology in non-traditional venues.

35           Appointments to the commission shall be made within 30 days of the Governor's  
36 approval of this Resolve.

37           The commission shall report to the Governor and the general court the results of its study  
38 and recommendations by filing the same

39           with the Governor and the clerk of the house of representatives within 180 days of the  
40 appointments to the Commission.
