In the One Hundred and Ninety-Second General Court (2021-2022)

An Act increasing penalties for hit and runs with recreational vehicles in the Commonwealth to be known as the James Ward Act.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:
