An Act relative to reasonable compensation for equitable representation.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 11 of chapter 211D of the General Laws is hereby amended by  
2 striking subsection (a), and inserting the following subsection:- (a) The rates of compensation  
3 payable to all counsel, who are appointed or assigned to represent indigents within the private  
4 counsel division of the committee in accordance with the provisions of paragraph (b) of section  
5 6, shall, subject to appropriation, be as follows: for homicide cases the rate of compensation shall  
6 be \$110 per hour; for superior court non-homicide cases, including sexually dangerous person  
7 cases, the rate of compensation shall be \$75 per hour; for district court cases and children in need  
8 of services cases the rate of compensation shall be \$60 per hour; for children and family law  
9 cases and care and protection cases the rate of compensation shall be \$75 per hour; for sex  
10 offender registry cases and mental health cases the rate of compensation shall be \$60 per hour.  
11 These rates of compensation shall be reviewed periodically at public hearings held by the  
12 committee at appropriate locations throughout the state, and notice shall be given to all state,  
13 county and local bar associations and other interested groups, of such hearings by letter and

14 publication in advance of such hearings. This periodic review shall take place not less than once  
15 every 3 years.

16 SECTION 2. Section 11 of chapter 211D of the General Laws is hereby amended by  
17 striking subsection (a), and inserting the following subsection:- (a) The rates of compensation  
18 payable to all counsel, who are appointed or assigned to represent indigents within the private  
19 counsel division of the committee in accordance with the provisions of paragraph (b) of section  
20 6, shall, subject to appropriation, be as follows: for homicide cases the rate of compensation shall  
21 be \$115 per hour; for superior court non-homicide cases, including sexually dangerous person  
22 cases, the rate of compensation shall be \$80 per hour; for district court cases and children in need  
23 of services cases the rate of compensation shall be \$62 per hour; for children and family law  
24 cases and care and protection cases the rate of compensation shall be \$80 per hour; for sex  
25 offender registry cases and mental health cases the rate of compensation shall be \$62 per hour.  
26 These rates of compensation shall be reviewed periodically at public hearings held by the  
27 committee at appropriate locations throughout the state, and notice shall be given to all state,  
28 county and local bar associations and other interested groups, of such hearings by letter and  
29 publication in advance of such hearings. This periodic review shall take place not less than once  
30 every 3 years.

31 SECTION 3. Section 11 of chapter 211D of the General Laws is hereby amended by  
32 striking subsection (a), and inserting the following subsection:- (a) The rates of compensation  
33 payable to all counsel, who are appointed or assigned to represent indigents within the private  
34 counsel division of the committee in accordance with the provisions of paragraph (b) of section  
35 6, shall, subject to appropriation, be as follows: for homicide cases the rate of compensation shall  
36 be \$120 per hour; for superior court non-homicide cases, including sexually dangerous person

37 cases, the rate of compensation shall be \$85 per hour; for district court cases and children in need  
38 of services cases the rate of compensation shall be \$65 per hour; for children and family law  
39 cases and care and protection cases the rate of compensation shall be \$85 per hour; for sex  
40 offender registry cases and mental health cases the rate of compensation shall be \$65 per hour.  
41 These rates of compensation shall be reviewed periodically at public hearings held by the  
42 committee at appropriate locations throughout the state, and notice shall be given to all state,  
43 county and local bar associations and other interested groups, of such hearings by letter and  
44 publication in advance of such hearings. This periodic review shall take place not less than once  
45 every 3 years.

46 SECTION 4. Section 1 of this act shall take effect on July 1, 2021.

47 SECTION 5. Section 2 of this act shall take effect on July 1, 2022.

48 SECTION 6. Section 3 of this act shall take effect on July 1, 2023.
