By Mr. Kushmerek of Fitchburg, a petition (accompanied by bill, House, No. 2108) of Michael P. Kushmerek and others that the Department of Mental Health establish a pilot program of assertive community treatment to treat individuals under the age of 22. Mental Health, Substance Use and Recovery.

The Commonwealth of Massachusetts

**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act relative to a PACT pilot program for children.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Notwithstanding any general or special law to the contrary and subject to appropriation,
2 the department of mental health shall establish a 3-year pilot program of assertive community
3 treatment to treat individuals under the age of 22 who: (1) exhibit symptoms of serious emotional
4 disturbance; (2) demonstrate an inability to consistently use less intensive levels of care in the
5 community; and (3) have functional impairment and a history of difficulty in functioning safely
6 and successfully in the community, school, home, or workplace.

7 The pilot program shall include mental health services and social service assistance to
8 eligible individuals through a person-centered approach, which may include, but not be limited
9 to: (1) clinical assessment and outreach; (2) medication treatment and outreach; (3) care
10 coordination, including with primary care; (4) symptom management; (5) harm reduction; (6)
11 family services; (7) housing support; and (8) any needs that arise in carrying out the acts of daily
12 living. The pilot program shall include a team-based approach to service delivery and shall tailor

13 services to the specific needs and acuity of each individual eligible for the program. To the
14 maximum extent possible, the program shall be consistent with the evidence-based practice
15 standards for Assertive Community Treatment as found in SAMHSA's Assertive Community
16 Treatment (ACT) Evidence-Based Practices (EBP) KIT. Services offered through the pilot
17 program shall not be limited to a specific physical location.

18 The department of mental health shall report not later than 12 months after the effective
19 date of this act and annually thereafter to the house and senate committees on ways and means
20 and the joint committee on mental health, substance use and recovery the progress and results of
21 the pilot program and any identified barriers and challenges to treatment for the aforementioned
22 treatment group.
