An Act to establish a commission to study substance use disorder and treatment disparities in the minority community.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           “SECTION XX. There shall be a commission established to study the disproportionate  
2 impact substance use disorders and overdoses have on the minority community of the  
3 commonwealth and corresponding disparities in substance use disorder treatment access. The  
4 commission shall: 1) review current data and trends regarding substance use and overdose rates,  
5 disparities in treatment access, and corresponding causes in the minority community; 2) evaluate  
6 the effectiveness of current treatment interventions within minority communities; 3) identify  
7 barriers to accessing treatment, including lack of necessary resources, education, access and  
8 training to medical needs, and the need for culturally appropriate care and intervention; and 4)  
9 recommend evidence-based strategies to reduce overdose deaths and to improve access,  
10 treatment, and education in the minority community.

11           The commission shall consist of the following members or a designee: the secretary of  
12 health and human services, who shall serve as chair; the commissioner of the department of  
13 public health; a representative of the Bureau of Substance Addiction Services; and 8 members  
14 appointed by the governor, 2 of whom shall be representatives from advocacy organizations with  
15 expertise in substance use disorders and treatment, 2 of whom shall be representatives from  
16 advocacy organizations with expertise in racial disparities in health care, 1 of whom shall be a  
17 representative of community health centers located in a culturally diverse location, 1 of whom  
18 shall be a provider primarily serving the minority community, 1 of whom shall be an expert in  
19 substance use disorder treatment with a focus on the minority community, and 3 of whom shall  
20 be representatives of geographically diverse organizations that promote the well-being of  
21 culturally diverse populations through culturally competent behavioral health.

22           The commission shall file its report, including any recommendations, with the clerks of  
23 the house of representatives and senate, the joint committee on mental health, substance use and  
24 recovery and the house and senate committees on ways and means annually not later than  
25 January 1 of each year.”
