Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1.

2 Section 157 of chapter 140 of the General Laws, as appearing in the latest official edition, 3 is hereby amended by inserting after subsection (c) (vii) the following subsection:- c (viii) that 4 all dogs deemed as dangerous shall have a mandatory evaluation and regular meetings as prescribed by a Diplomate of the American Veterinary Society of Animal Behavior, non-5 6 veterinary Certified Applied Animal Behaviorist, or a veterinarian that is familiar with and uses 7 methods that follow the position statements of the American Veterinary Society of Animal 8 Behavior. Should the behaviorist/veterinarian believe the dog will benefit from training, she/he 9 will recommend a trainer. The trainer will act to help implement the plan created by the 10 behaviorist/veterinarian and maintain regular communication with the associated 11 behaviorist/veterinarian. Recommended trainers must exclusively employ evidence-based 12 training techniques that do not result in pain, discomfort, fear, or anxiety. Electronic, prong, or

13 choke collars must not be used. All professionals involved shall be educated in and use methods 14 that adhere to principals outlined by the American Veterinary Society of Animal Behavior. 15 SECTION 2. 16 Section 157 of chapter 140 of the General Laws, as appearing in the latest official edition, 17 is hereby amended by inserting in subsection (d) after the words, "keeper of a dog" the following 18 words:- complainant /victim. 19 SECTION 3. 20 Section 157 of chapter 140 of the General Laws, as appearing in the latest official edition, 21 is hereby amended by inserting in subsection (e) (1) after the word, "keeper" the following 22 words:- complainant/victim. 23 SECTION 4. 24 Section 157 of chapter 140 of the General Laws, as appearing in the latest official edition, 25 is hereby amended by inserting in subsection (e) (2) after the words, "in violation of this section" 26 the following words:-, in non-compliance of veterinarian/behaviorist recommendations. 27 SECTION 5. 28 Section 157 of chapter 140 of the General Laws, as appearing in the latest official edition, is hereby amended by inserting in subsection (h) after the words, "in violation of an order issued 29 30 under this section" the following words:-, or veterinarian/behaviorist recommendations.
