**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act to define clinical social work practice.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 130 of Chapter 112 of the General Laws, as so appearing in the
2 2018 General Laws, is hereby amended by striking out the definition “The independent practice
3 of clinical social work” and inserting in place thereof the following definition:-

4 “Clinical social work practice”, social work performed by Master's level social workers
5 applying evidence informed theories and methods in the comprehensive assessment and
6 treatment of cognitive, affective, and behavioral disorders and distress arising from physical,
7 environmental, psychological, emotional or relational conditions. The scope of clinical social
8 work practice includes, but is not limited to: assessment; evaluation; psychotherapy and
9 counseling for individuals, families, and groups; client-centered advocacy; consultation and
10 supervision; and case management services. Clinical social workers practice within an ecological
11 and ethically-principled framework in the areas of competence their education and training
12 reflects. Social work practice is multi-systemic, trauma-informed, and committed to public health

- 13 and well-being. Social work's commitment to racial, economic, and social justice is central to the
- 14 National Association of Social Workers Code of Ethics.
